Bedford County of the Commonwealth of Pennsylvania to the Sheriff of Bedford County Greeting: Whereas Rebekah Thomas lately in our County Court of General quarter Sessions of the year for Bedford County aforesaid at January Sessions 1812 was presented by the Grand Jurors of the said County, that she the said Rebekah Thomas did commit fornication with some person to said Jurors unknown; Contrary to the Act of Assembly in such case made and provided. Therefore We Command you as heretofore we Commanded you that you take the said Rebekah Thomas if she be found in your Jurisdiction so that you have her body before our Judges at Bedford at our County Court of General quarter Sessions of the year then to be held the first Monday of August next to answer to said Indictment &c And have you then there this writ. Witness my hand at Bedford the sixth day of April Anno Domini one thousand eight hundred and twelve

Tax Records and Their Cousins, the PA Septennial Census

WHILE the reaction to taxes in the present usually evokes emotions ranging from just this side of scorn, genealogists are always happy when their ancestors appear on tax lists since these documents almost always pinpoint the township, borough or city of residence. Once such residence is determined, it can be used by the researcher to make a decision on what other records (such as the registers of a particular area's churches) logically should be consulted.

Tax lists

Tax records are usually found in county tax assessors' offices in Pennsylvania. In many instances, early lists have been transcribed or microfilmed and can be found at county historical societies. The State Archives also has a respectable set of

1058 - HISTORY OF WYANDOT COUNTY.

SOLOMON **RONK** was born March 1, 1834. He is a son of Jacob and Anna M. (Van Buskirk) Ronk, and native of Bedford, Cuyahoga Co., Ohio. His parents were natives of Pennsylvania and Virginia respectively, of German and Scotch lineage; were married in Tuscarawas County, Ohio. his father being engaged in stone work, contractor. etc. In 1834, the family moved to Seneca County, and in 1848, or near that time, purchased land in this county. The children were named as follows: Sarah A., Sophia, William, Solomon, Mary A., Melinda, Eliza J., Melissa and Cordelia, all living but William and Mary A. The father died October 8, 1873, in his seventieth year, the mother now resides in York State in her seventy-fifth year. At the age of twenty-two, Solomon Ronk began operations for himself working by day's work in various parts of the country. He was married, December 31, 1861, to Margaret A. Cox, who was born in Crawford County, Ohio, February 2, 1833. Her parents were William and Sarah (Ward) Cox, natives of Ohio and Virginia, and of English and Scotch descent Their children were George, Lydia J., Margaret A., Emma T., Sarah, John, Mary L., Eliza and William, the two latter deceased. The mother died August 5, 1878. To Mr. and Mrs. Ronk were born six children-William E., Iva M., Edward J., George W., Jacob E. and Anna A. Edward J. died in infancy. Mr. Ronk farmed rented land a few years, and then purchased eighty acres in Mifflin Township, though still renting for some time. He finally traded his eighty acres for forty-eight in Crane Township, where he resided till 1882, when he sold out and purchased 185 acres in Tymochtee where he now lives, owning 160 acres also in Jay County, Ind. He is a Republican, and, with Mrs. Ronk, a member of the Methodist Episcopal Church.

The last will and testament of Andrew Collins of Southampton Township, Bedford County, State of Penna. I Andrew Collins considering the uncertainty of this mortal life, and being of Sound mind and memory blessed be Almighty God for the same do make and publish this my last will and testament in manner and form following, that is to say, 1st I will that all my just debts as shall be by me owing at my death together with my funeral expenses and all charges touching the proving of or otherwise concerning this my last will shall in the first place out of my estate and effects be fully paid and satisfied. 2d I will and bequeath to my beloved wife Eliza Collins all my effects both personal and real property except the last tract of land I purchased from the Executors of A. Kerns decd., she to have and to hold the same during her natural lifetime. 3d I will that my three oldest sons James, Isaiah and John take the tract of land excepted or last purchased from the Executors of A. Kerns deceased and finish paying for the same and to have the same to their own use and I also give them all I have paid on said land and to take immediate possession of

Thomas Jefferson President of the United States of America,
To all to whom these presents shall come, greeting:

Know ye, That, in consideration of military services performed by Edmund Fortin in England for three years in the Virginia Line of Continental Establishment, and in pursuance of an Act of the Congress of the United States, passed on the 20th day of August in the year 1790, entitled "An Act to enable the Officers and Soldiers of the Virginia Line on Continental Establishment to claim titles to certain lands lying north-west of the River Ohio, between the little Miami and Tinto; and another Act of the said Congress, passed on the 6th day of July in the year 1794, amendatory of the said Act, there is granted by the said United States unto James Lemmon, a certain tract of land, containing *Two hundred acres* situate between the little Miami and Tinto Rivers, north-west of the River Ohio, as by survey bearing date the *thirty first* day of August in the year one thousand seven hundred and *ninety eight* and bounded and described as follows, to wit, *Section of two hundred acres of land on Military warrant N^o 375, in favor of the said Edmund Fortin for a like quantity, on Meigs Creek, Beginning at a well known corner long white oak one of the oaks marked IL, Northwesterly corner to the Fortin's survey N^o 337 1/2 running with Fortin's line South thirty four degrees East three hundred poles crossing the North Fork at one hundred and two and the South fork at two hundred and thirty five poles to three Ashes, Southwesterly corner to said Fortin's survey, thence South eight three degrees West one hundred and thirty eight poles to a poplar, southerly corner of Richard Thomas North thirty five degrees West three hundred poles crossing Meigs Creek at two hundred poles to three white oaks and a black oak, thence North eighty three degrees East one hundred and thirty eight poles to the Beginning,*

with the appurtenances: **To have and to hold** the said tract of land, with the appurtenances unto the said James Lemmon his heirs and assigns forever

In Witness whereof, the said *Thomas Jefferson* President of the United States of America, hath caused the Seal of the United States to be hereunto affixed, and signed the same with his hand at Philadelphia, the City of Pennsylvania, ~~the 26~~ *the 26* day of July in the year of our Lord one thousand seven hundred and ~~seventy nine~~ *seventy nine* and of the Independence of the United States of America the twenty ~~fourth~~ *fourth* day of July 1801
